MEDICAL RELEASE:

In the event there is an emergency during at First Congregational Church of Naperville (FCC) youth event involving the child named hearin and I cannot be contacted, I give FCC permis- sion to seek emergency medical treatment, especially in life-threatening conditions, and accept said treatment as proper under the circumstances involved. My signature at the bottom of this form is intended to serve as a medical release.

RELEASE OF LIABILITY AND INDEMNITY AGREEMENT/MINOR:

(1) I, the undersigned, as parent or guardian of the above named minor, hereby agree to allow said minor to participate in the activities that occur at First Congregational Church or that are sponsored by First Congregational Church and occur at other premises.

(2) I realize that unanticipated and unexpected events may arise during and associated with youth group activities. I voluntarily agree to accept any and all risks of injury, death or dam- ages of any nature resulting directly or indirectly from named minor's participation in these activities.

(3) In consideration of the benefits provided by First Congregational Church, I hereby agree that neither I, my successors, assigns nor anyone acting on my behalf will make claim against or sue First Congregational Church, its officers, Board, agents or employees as a result of my child's participation in youth group activities. In addition, I hereby release First Congregational Church, its officers, Board, agents and employees from all claims or lawsuits that I, my successors, assigns or anyone acting on my behalf may now have or may hereafter at any time have for injury or damage:

- (A) Resulting from the condition of any First Congregational Church facility that has been reasonably maintained,
- (B) Suffered by the child/youth named hearin while participating in or traveling to and from the activities, or
- (C) Suffered by the child/youth named hearin in any other activity associated with the activities aforementioned.

This release does not apply to intentional and/or willful acts of misconduct by First Congregational Church or any of its officers, Board, agents or employees.

(4) Any controversy between the parties regarding a claim against First Congregational Church or the construction or application of this agreement shall be settled by mediation, and if necessary, legally binding arbitration in accordance with the *Rules of Procedures for Christian Conciliation*. The parties expressly agree to waive their right to file a lawsuit against one another in any civil court for such disputes except to enforce an arbitration decision. Each party agrees to pay their own attorney fees and to evenly share in the costs and fees of the mediation or binding arbitration.

(5) I understand that this agreement and release of liability is enforceable against me only as parent or guardian of said minor on this form. This agreement and release of liability may not be enforceable against named minor when he/she becomes of legal age. Therefore, in further consideration for permitting named minor to participate in the activities listed on indi- vidual permission slips, I agree to defend and hold harmless First Congregational Church, its officers, Board, agents, employees and volunteers against any claim or lawsuit for injury. This includes loss or damage arising from or in any way connected with named minor's participation in the activities, including any injury, loss or damage resulting from the condition of any facility or from negligence, carelessness or other acts of First Congregational Church, its officers, Board, agents and employees. I also agree to reimburse First Congregational Church, its officers, Board, agents and employees for any loss, damage, liability, cost or expense they suffer as a result of any such claim or lawsuit brought against First Congregational Church by named minor.

(6) I have carefully read this agreement and fully understand its contents. I am aware that this is a release of liability and indemnity and that it is a legally binding contract between First Congregational Church and me and I sign it of my own free will.
